Vitalization Grants are not available to offset already existing expenses or for programs/activities that are receiving denominational redevelopment funds.

Vitalization Grants may be renewed for up to two additional years.

A congregation may receive a Vitalization Grant for a maximum of three consecutive years.

A Vitalization Grant may include capital expenditures that relate directly to the core purpose of the Grant request.
