November 18, 2023 Praise Community Church / GKI LA, Covina

ASSEMBLE IN GOD'S NAME

The Presbytery of San Gabriel convened on Saturday, November 18, 2023, at 9:00 am, in person at Praise Community Church, in Covina. A quorum was present as reflected in the roll. Moderator RE Pat Martinez-Miller called the meeting to order at 9:04 am. TE Wendy Tajima was the Stated Clerk for the meeting.

ENGAGE IN GOD'S WORK

OPENING WORSHIP

The Presbytery of San Gabriel was invited into worship with a recorded video of Inquirer Veronica Ota, singing *Holy Spirit* as a prelude. TE Peter Tan-Gatue, pastor of Praise Community Church, welcomed the Presbytery members. In honor of Native American Heritage Month, the Presbytery opened in worship singing *O God, the Creator*, a hymn written by Elizabeth Thunderbird Haile of the Shinnecock people, and TE Cecil Corbett of the Nez Perce / Choctaw people who was a Presbyterian pastor. RE Mona Morales Recalde, member of the Gabrieleño / Tongva San Gabriel Band of Mission Indians, gave a land acknowledgement and opened the meeting in prayer.

There was an exception as the Presbytery did not hold an annual Financial Review.

Executive Presbyter's Report

TE Wendy Tajima reported on the State of the Presbytery; see attached.

Administration and Finance Committee

TE Roberto Ramírez reported for the Committee.

TE Roberto Ramírez reported on the Q3 financials, and noted that there is a Property Team reviewing the best use of real estate assets of the Presbytery. He also stated that the budget task force presented a budget draft to the Executive Commission. CRE Sam Bang gave a summary of said proposed budget for 2024, which is recommended for adoption by the Executive Commission.

With no second needed as the motion came from the Executive Commission, the Presbytery moved and voted to adopt the 2024 Budget.

TE Roberto Ramírez then made a motion from the floor that the apportionment for 2024 be \$70 per member, which is unchanged from 2023.

The Presbytery moved, seconded, and voted to set the apportionment for 2024 at \$70 per member.

Education, Equipping, and Empowerment

RE Helen Darsie reported for the Committee.

RE Helen Darsie thanked the Presbytery members who gave input through the Fall Interest Survey, and introduced CRE Sam Bang, who gave a short report of highlights from the survey. He highlighted the Presbytery's interest in caring for our unhoused neighbors and in strengthening the bonds we have with our local Indigenous hosts – the Gabrieleño / Tongva San Gabriel Band of Mission Indians.

RE Helen Darsie then promoted the upcoming WinterFest in February 2024, including the schedule of sessions. She also presented the offer of \$100 gift certificates to Homeboy Industries for the top five most intergenerational church teams.

Commission on Ministry

TE Cyndie Crowell reported for the Commission.

She reported on the recommendation to commission two ruling elders to provide pastoral services for Emmanuel Hispanic Presbyterian Church in Claremont. She introduced RE Jorge Gomez and RE Rosario Orosco, who each read their statement of faith. The Presbytery asked several questions of them.

TE Cyndie Crowell presented the terms of call for RE Jorge Gomez and RE Rosario Orosco, each as ¼-time Commissioned Ruling Elders for pastoral service.

With no second needed as the motion came from the Commission on Ministry, the Presbytery moved and voted to commission Ruling Elder Jorge Gomez and Ruling Elder Rosario Orosco, each as a 25%-time Commissioned Ruling Elder for pastoral service for Emmanuel Hispanic Presbyterian Church in Claremont, for a one-year contract effective October 1, 2023, with a sixmonth evaluation on April 1, 2024, for review of salary, possibly expanding the commission, and further differentiating the job descriptions. TE Amy Mendez will continue as Moderator of the Session and supervisor for both CREs. Terms of call for each CRE as below.

TE Cyndie Crowell asked them the constitutional questions for CREs, and upon their affirmative answers, she congratulated CRE Jorge Gomez and CRE Rosario Orosco as they enter the ministry.

TE Crowell then explained the recommendation for leadership at Filipino Community United Presbyterian Church, who has requested the approval of a six-month agreement with TE Bear Ride and Dr. Tracey Shenell to provide pastoral service. TE Ride would be the Bridge Pastor of record at ¼-time, moderating Session, serving sacraments, and acting as head of staff. Dr. Shenell would be the Director of Ministry at ¾-time, leading in worship, providing pastoral care, leading in vision development and community outreach, and doing administration. Dr. Shenell holds an M.Div. and D.Min. from Fuller, and

has pastoral experience, but is relatively new to the PC(U.S.A.). The hope is by the end of the six-month agreement, she and the church will confirm that it is God's will for her to seek authorization as a PC(U.S.A.) pastor, likely as a Commissioned Ruling Elder.

With no second needed as the motion came from the Commission on Ministry, the Presbytery moved and voted to approve TE Bear Ride as Bridge Pastor and Moderator of Session for Filipino Community United Presbyterian Church, at 25%-time, from November 1, 2023, to April 30, 2024, with compensation as outlined below.

With no second needed as the motion came from the Commission on Ministry, the Presbytery moved and voted to affirm Dr. Tracey Shenell's pastoral service to Filipino Community United Presbyterian Church, at 75%-time, from November 1, 2023, to April 30, 2024, with compensation as outlined below.

TE Cyndie Crowell introduced TE Deetje Tiwa, a member of San Francisco Presbytery. TE Tiwa has come to Southern California to serve as interim pastor for GPIB-USA, the Indonesian fellowship in Claremont. As TE Tiwa is retired, the Presbytery followed the practice that retired teaching elders do not need to read their statement of faith, nor leave the room for voting. Since GPIB-USA does not recognize the jurisdiction of the Presbytery, her terms of call are not being voted on. TE Crowell confirmed that COM has met with TE Tiwa and recommends that she be received by the San Gabriel Presbytery as a minister member. TE Deetje Tiwa introduced herself, and the Presbytery asked several questions of her.

With no second needed as the motion came from the Commission on Ministry, the Presbytery moved and voted to receive TE Deetje Tiwa as a minister member of the Presbytery of San Gabriel, upon her transfer from the Presbytery of San Francisco.

TE Cyndie Crowell then celebrated the work that GKI LA's leaders have done to get to this point of being recommended for chartering with the PC(U.S.A.). She thanked the committee, made up of Rev. Ann Oglesby-Edwards, Rev. Bryce Little, and Rev. Peter Tan-Gatue (the pastor of GKI LA's partnering congregation), who walked with them through elders training, the development of a mission study, financial forecast and full revision of their bylaws in order to align with the Constitution of the PC(U.S.A.). TE Crowell invited TE Oglesby-Edwards to speak.

TE Ann Oglesby-Edwards reviewed the work with GKI LA over the years, and thanked Praise Community Church for their support of GKI LA, especially in modeling so well the work of Session. After giving a summary of all the work that had been done, the committee then recommended to COM that GKI LA be chartered as a PC(U.S.A.) congregation.

With no second needed as the motion came from the Commission on Ministry, the Presbytery moved and voted to approve the chartering of GKI LA as a member church of the Presbytery, through a chartering commission with members as follows:

Ruling Elder Pat Martinez-Miller Ruling Elder Seree Yenjai Teaching Elder Peter Tan-Gatue, Moderator of the Commission Teaching Elder Ann Oglesby-Edwards Teaching Elder Deetje Tiwa.

The chartering service is scheduled for Sunday, March 3, 2024, at 3pm, at the home of GKI LA and Praise Community Church.

Lastly, TE Cyndie Crowell ended her report by praying for all the aforementioned ministries and their newly commissioned leaders:

CRE Jorge Gomez and CRE Rosario Orosco at Emmanuel Hispanic Presbyterian Church TE Bear Ride and Dr. Tracey Shenell at Filipino Community United Presbyterian Church TE Deetje Tiwa at GPIB-USA The congregation of GKI LA.

The Presbytery meeting took at 15 minute break, with Vice-Moderator Peter Tan-Gatue assuming the role of Moderator after the break. The Presbytery was called back to the meeting with a recorded video of Interwoven New Worshiping Community, singing *Come On and Bless the Lord*.

Executive Commission

TE Dave Tomlinson reported for the Commission.

TE Dave Tomlinson introduced the Presbytery's Executive Commission (PEC) report, mentioning that the budget was presented by the Administration and Finance Committee. The PEC approved the meeting scheduling for 2024, which is included in the Presbytery Meeting packet. He also indicated that the sale of the property of the former St. Andrew's Presbyterian Church has been closed, and the Presbytery received \$1.7 million in net proceeds. TE Tomlinson then called TE Cyndie Crowell forward to present the report from the Administrative Commission for Eagle Rock Presbyterian Church.

TE Cyndie Crowell gave background on the work of the Administrative Commission, as well as the recommendations to the Presbytery. She introduced TE Harlan Redmond to share the vision of Interwoven in a renovated Eagle Rock location.

With no second needed as the motion came from the Administrative Commission for Eagle Rock Presbyterian Church, the Presbytery moved and voted to commit to plan for the renewal of ministry at the site of Eagle Rock Presbyterian Church, with investment in the major renovation of the property, with the eventual goal of establishing Interwoven there, and that the Eagle Rock Administrative Commission be expanded to provide care and oversight for the following:

- 1. The current Eagle Rock Presbyterian Church
- 2. Renovation of the property
- 3. Interwoven New Worshiping Community as it moves to Eagle Rock and progresses toward chartering as a congregation.

With no second needed as the motion came from the Administrative Commission for Eagle Rock Presbyterian Church, the Presbytery moved and voted to:

• affirm the election of TE Harlan Redmond and RE Carolyn Harris

- accept the resignations of RE Ellery Atienza and TE Wendy Tajima
- elect TE Deidra Goulding
- affirm the full involvement of Bryan Quintas of Interwoven

related to membership on the Administrative Commission for Eagle Rock Presbyterian Church.

TE Wendy Tajima presented the statistics for the year.

The Presbytery moved, seconded, and voted to receive the Report on Representation.

TE Wendy Tajima thanked those who have completed their terms of service to the Presbytery in 2023. With gratitude for those stepping forward to serve, TE Tajima presented the slate of nominees on behalf of the Committee. There was an opportunity to bring nominations from the floor.

Justice, Peacemaking, and Mission Committee

TE N'Yisrela Watts-Afriyie reported for the Committee.

TE N'Yisrela Watts-Afriyie introduced the Presbytery Offering for the month of November, including two ways to be channels of God's blessing. She invited RE Mona Morales Recalde and Wendy Gist to describe them. RE Mona Morales Recalde described her tribe, the Gabrieleño / Tongva San Gabriel Band of Mission Indians, and its work to distribute gift cards to all Native Americans in need in the LA area. Wendy Gist described the gifts of cold-weather and travel gear for migrants being released from the Desert View Annex near the Adelanto Detention Center, which goes with the additional emergency funds given by Presbyterian Disaster Assistance. Wendy Gist also encouraged people to give money during today's closing worship, which would be used to purchase gift cards for Native neighbors in need.

TE N'Yisrela Watts-Afriyie presented the 2024 grants for the El Monte Initiative: \$34,000 to Puente de Esperanza Presbyterian Church for the CaliCenter community services program, and \$15,000 to Community Church of El Monte for the Food Pantry.

She closed her report by reminding the Presbytery of the Christmas Joy Offering in December.

TE N'Yisrela Watts-Afriyie called for an offering, and prayed over it after receiving.

REDRESS OF IMBALANCE

Annually, the stated clerk shall ascertain the number of resident Teaching Elders (TEs) duly enrolled and the number of Ruling Elders (REs) churches are entitled to send as commissioners.

In the past the <u>Book of Order</u> established the number of REs particular churches are entitled to send as commissioners according are as follows: under 501, 1 elder; 501-1000, 2 elders; 1001-1500, 3 elders; 1501-2000, 4 elders; 2001-3000, 5 elders; 3001+ 1 more elder for each 1,000 additional active members or major fraction thereof. In addition to commissioners from churches Commissioned Ruling Elders and the RE members of Presbytery Council are also elder commissioners.

When the number of Teaching Elders is larger, the stated clerk shall report the imbalance to the presbytery for the purpose of redressing the imbalance between Teaching Elders and Ruling Elders. The stated clerk shall then assign additional Ruling Elder commissioners to the particular churches according to the following priorities:

- a. double the commissioners allocated by the **Book of Order**, and;
- b. By action of the Presbytery Council, Sept. 30, 2014, the reverse alphabetical additions from past years were removed and every church was granted one additional RE representative to presbytery. By this means all churches benefit equally.

NOTE: Presbytery has voted to use active participation of honorably retired members as a criterion in determining balance. (54 non-participating minister members were noted in determining balance.)

Ruling Elder commissioners elected by the particular churches shall be enrolled as members of presbytery upon filing with the stated clerk a certification of election by registering.

WHO MAY VOTE AT PRESBYTERY MEETINGS

The voting members at presbytery meetings are as follows:

- 1. Elder commissioners from the churches or duly elected alternates when the elder commissioner is not present.
- 2. Minister members of the presbytery including temporary minister members (but <u>not</u> corresponding members) from other denominations.
- 3. The Moderator and Vice-Moderator of presbytery.
- 4. Elder members of the Presbytery Executive Commission including the immediate previous-year moderator of presbytery who chairs the Executive Commission.
- 5. Any Commissioned Ruling Elder who was given the right to vote as a provision of the commission.

Note: <u>Members of presbytery committees</u> do <u>not</u> have a vote at presbytery meetings unless they qualify under a provision of 1-5 above. No one may vote or cast a ballot on behalf of another member; <u>you must be present to vote</u>.

<u>Corresponding members</u> of presbytery have voice but not vote.

Presbytery of San Gabriel Executive Presbyter's Report November 18, 2023

John 6:60-61, 66-69

⁶⁰ When many of his disciples heard it, they said, "This teaching is difficult; who can accept it?" ⁶¹ But Jesus, being aware that his disciples were complaining about it, said to them, "Does this offend you?"

⁶⁶ Because of this many of his disciples turned back and no longer went about with him. ⁶⁷ So Jesus asked the twelve, "Do you also wish to go away?" ⁶⁸ Simon Peter answered him, "Lord, to whom can we go? You have the words of eternal life. ⁶⁹ We have come to believe and know that you are the Holy One of God."

If I had to look back on this year, I can't help but see how I started the year in Israel and Palestine, and we are all now immersed in worry over Israel and Palestine. In between these two bookends, there is much that I celebrate about the life of this presbytery—so much so that I feel unsettled that we have been so blessed when so many are suffering. When I think about 2023 in San Gabriel Presbytery, here is what comes to my mind:

- Early on, we had a WinterFest that named two key priorities for the presbytery at large: our growing relationship with the **Gabrieleno/Tongva tribe**, and our efforts to contribute to the call for **affordable housing** in our area. In fact, two state bills that we advocated for—both of which passed—are AB 776, which Gov. Newsom signed last month on Indigenous People's Day, which renames the 210 freeway and requires the erection of highway signs to acknowledge and honor the first peoples of this land; and SB 4, which waives the zoning restrictions if churches seek to use some of their property for affordable housing. We are now looking to continue supporting our Indigenous neighbors, such as with today's offering which will help the tribe to provide assistance to all Native Americans in Los Angeles. And we are looking for ways to offer space for affordable housing—which will also contribute to our resources for ministry.
- We are making significant progress in several Presbytery priorities. Habitat for Humanity has been clearing out the Baldwin Park property, and they gained public funding for the building of the new housing that will be sold to local families, and the new house and adjoining units for the Presbytery, that we may continue to be a faithful presence in Baldwin Park. The work of several administrative commissions—Baldwin Park, Grace Los Angeles, St. Andrew's, and Eagle Rock—has either been completed or hit major milestones. And Wendy Gist has been a great organizer for the immigrant ministry efforts across the Synod.
- Our **new worshiping communities** continue to develop their ministries:
 - o You will hear today about a commitment being proposed to support Interwoven's vision.
 - o At our September Presbytery meeting, we celebrated God's blessing on the ministry that is now called Live Oak Community Church in Temple City.
 - Haven New Worshiping Community's relationship with Claremont Presbyterian Church has become a catalyst for the whole Claremont community to coalesce in their care for LGBTQ residents and their families.

- O You will be asked today to approve the chartering of GKI LA, which will become the first Indonesian member church in our presbytery.
- We are finding gifted and well-suited **pastoral leaders** for our churches, such as Occidental, Altadena, Emmanuel, FCUPC Azusa—and several of us have helped with Eagle Rock. Frankly, finding the best pastors and preachers has not been easy post-COVID, and I have spent an extraordinary amount of time and energy either filling the pulpit or looking for guest preachers in the last couple of years for churches without pastors. It is a blessing to worship with folks, and I thank God for many who have been willing to help, but this has been a big part of my work in the last year or two.
- We have gained **new energy, expertise, and perspective from new friends**, or significant visits from thought leaders like Bruce Reyes-Chow. As we hear from folks who have recently graduated from or are still in seminary—especially Princeton and Fuller—some of us have been challenged to learn about their markedly different concerns and priorities. Among other things, they are raising the need for the church to be more inclusive, to respond to climate change, and they are looking at social enterprise as a tangible connection with the community, and as a supplemental income source for the post-Christendom church.

And as we look ahead to 2024, there is much to celebrate. My hope is that WinterFest will again be a herald of what is to come, as we consider how we can grow together more as the Beloved Community. One of the things we are asked the most is to help build relationships across the presbytery. And while I brag about our diversity, I know that we have not done near enough to learn from each other about our different experiences and perspectives that would give us a larger view of the grace of God. A couple of plans are already in place to build on this. One is our annual work day on June 15th. That work day was one attempt at bringing folks together over service projects, and our hope this year is that we will work with each other and also with the **Tongva Taraxat Paxaavxa Conservancy**—the first landback in Los Angeles.

And during the season of Lent, we are proposing a Presbytery-wide series of meetings, called **Growing as the Beloved Community,** for all members of the presbytery to see and hear each other in meaningful ways, pushing beyond the easy and inaccurate narratives that block our vision of who God has put us together with as one body of Christ. We are even suggesting that churches use this series as your Lenten study for 2024, as together we reflect on the incredible gifts God has given us in our own experiences and in each other—and the ways we dismiss or minimize them.

As I mentioned, I do believe we have been unusually blessed this year. Obviously this is not my doing—as you'll hear later today, we have over 90 individuals elected to lead in various aspects of the Presbytery's ministry, and that doesn't count the congregational leaders, Synod and national church supporters, and community partners who help make it possible. And I am amazed at the ways God comes through for us, even when we fear that we don't have the resources to move forward.

However, I also know that there is much to fear and to grieve. St. Andrew's has closed down, and as much as we hope the people of Eagle Rock would embrace an exciting but very different new future, their church family as they have known it has been dissipated. We all have friends and colleagues who have passed away, or have moved away to other states. And the continuing uncertainty of COVID and other challenges of the world keep us unsettled. Even the prospect of

a series of meetings when we are asked to move beyond easy categorizations and assumptions about ourselves and each other can be unsettling. And, of course, there is so much suffering in the world—so if we are unusually blessed, as I believe we are, what is our responsibility to be a blessing to others?

The excerpts I read today from John 6 reflect the ways that the reality of Jesus' gospel proved to be too unsettling for some of his own followers. When he was healing the sick and feeding the crowds, they were too happy to follow. But when he started saying disturbing things about eating his flesh, they were understandably a little weirded out. As Jesus reflects in his question to his closest disciples, they were offended by the way Jesus would bring about our salvation. And honestly, wouldn't all of us wish that we could have Easter without Good Friday?

It is difficult to believe as Peter does, when things do not go the way we want or we think should happen. And we cannot assume that every shiny new object is God's answer to our concerns or uncertainties. But we are called to discern together the will of God, and to be faithful—not self-sufficient, not always cheerful, not even always successful, but faithful. And as we step forward in faith, and care for each other and the world around us, and as we confess that we must always rely on God's grace for every breath we take, we are freed of the burdens of pretending to be God, so that we may serve God in all the surprising ways God calls us. We have no way of knowing what comes next—but to whom can we go? We have come to believe and know that Jesus Christ is the Holy One of God. And if so, may we live, and love, and commit ourselves to the mission of Jesus Christ for this time, and this place. Thank you for listening, and considering. Amen.

The Justice Peacemaking and Mission Committee met on Zoom on Wednesday, January 17, 2024, with a quorum present, and makes the following report to the Presbytery.

FOR ACTION

In light of the Executive Commission voting to open every Presbytery meeting with a land acknowledgement, the Justice Peacemaking and Mission Committee recommends that the Presbytery of San Gabriel adopt the following as the standard acknowledgement for the Presbytery:

We acknowledge the land we inhabit today was once known as Tovangaar, the unceded land of the Gabrieleño-Tongva people. We show our respect to our Gabrieleño-Tongva hosts with whom we have partnered for decades, as well as all Indigenous people, past, present, and future, and honor their labor as original caretakers of this land. We acknowledge their presence and connection to this land. We respect their ancestral ways and knowledge.

May we strive for reconciliation and cultivate a harmonious relationship with the land and its original caretakers, promoting justice and equity for all. We commit to uplifting the Gabrieleño-Tongva people. We commit to acknowledge the history, and join together in caring for this land and join in partnership in supporting the First People of Los Angeles.

Thanks to JPM member, RE Mona Morales Recalde, member of the Gabrieleño-Tongva San Gabriel Band of Mission Indians and elected commissioner with the Los Angeles City/County Native American Indian Commission, who offered guidance for this acknowledgement, including noting San Gabriel Presbytery's long-standing partnership with the tribe.

Faith Journey- Tracey Shenell

I was born in Cairo, Illinois, on the Mason-Dixon Line, so I consider myself a Southern in many ways. My faith journey began at a young age when I started to question why God allowed my brother to die. My elders warned me, saying, "Chile, we don't question God. We will never understand His ways." Later in life, I understood that only the latter part was true. Despite the warnings from my elders, I continued questioning God, but I never felt chastised. Rather I sensed God's presence listening and drawing nearer.

My Christian upbringing shifted as my family dynamics changed, from Roman Catholic Church in Latin with my mother's family in Cairo, IL, to Baptist churches with my stepfather's family in Magee, MS, and Holiness Sanctified churches with my father in Southern, IL. When we relocated to Joliet, IL, my mom sent my brother and me to VBS at local churches. I attended youth group at an AME church in junior high with friends. These experiences gave me a general understanding and belief in the Triune God. But the sermons my grandma preached to me about God and life on our front porch took a deeper root. Grandma Brown helped me to see that God was not confined to four walls. She helped me to see how, despite our own brokenness, God's love and grace were sufficient. She taught me about liberation, justice, and the importance of loving others, but only if we can truly love ourselves. Her connection to God as she put her hands and feet in the soil taught me to honor, respect, and love God and all of creation.

Eventually, our family landed at Sacred Heart Parish, a Black Catholic Church. Here I learned the church's role in fighting injustice as we actively advocated and protested. In high school and later at DePaul University in Chicago, I continued to express my faith through the school through the Gospel Choir, drama, and dance. This allowed me to cultivate relationships with people from various expressions of faith. I became involved with InterVarsity and answered an altar during a Black College Student retreat. I realized that much of my faith had been about activities and a bit of belief but didn't really move me towards a transformed life. While studying for the LSAT, I sensed a call into ministry. This wasn't support by my family or Gospel Choir friends who didn't believe in women in pastoral ministry. I studied and began worshiping at a Church of God church, connected with the holiness movement Church of God-Anderson. I still doubted my own call as a woman in ministry and believed I'd mostly work with youth and at faith-based non-profits. After preaching my first sermon in class the encouragement and affirmation I received from Dr. Pannell, allowed me to begin to see myself as a preacher. I continued working in various aspects of ministry at the church and was eventually ordained locally at Pasadena Church of God, where I served as a bi-vocational pastor for 14 years before taking a break from ministry and continue my studies.

During that my time in my DMin studies, I embraced liberation and womanist theology and began to deconstruct White Jesus and other things I needed to unlearn from the evangelical church. I began to rebuild a progressive theology that allowed me to embrace all of me as a Black Woman who saw liberation and wholeness as a part of how we were called to live out our faith. During this time, I found my pastoral voice and continued to care for and walk with God's people in non-traditional ways. While finishing up my DMin , I was invited to apply as an associate pastor of a non-denomination church in DTLA that had been planted by a Korean Presbyterian Church. Here, I was able to embrace language to articulate what it meant to be fully inclusive of my LGBTQI+ siblings and to name many of the ways Whiteness had negatively impacted Black Indigenous People of Color and women. I'm grateful for the many places and expressions of faith that have shaped me. In this new season of life as a divorced single mother of two Black teens who question as much as I did. I am committed to cultivating healthy rhythms for myself, my family, and others as we continue to encounter God, who helps is helping us to navigate and address the brokenness in ourselves and the world. I don't know what the next chapter holds, but I'm committing to being open to the mysterious sovereign activity of God leading and guiding me.

Statement of Faith: Tracey Shenell

I believe in God, who self-reveals as the Trinity. Though the Trinity is a deep mystery, I affirm both the traditional understandings of the Triune God and newer and more expansive ways of understanding God's work in our world. I believe that God continues to reveal themself in ways we can understand and relate to today.

As Creator, for me, God is the Womb and Giver of Life. In complete sovereignty, God made themself known to the world as the Word made flesh through the womb of Mary, a girl who embraced her call, birthed, and raised a radically subversive child born under the empire. Jesus, the Incarnate Word, demonstrated life in the new realm where the captives are to be set free in body, mind, and soul and cultivate a more inclusive world. Like many with a prophetic voice, His message and lifestyle led to His state-sponsored execution. Yet, through God's sovereign and gracious power, His life, death, and resurrection were used to redeem and reconcile all who seek it, regardless of age, gender, race, ethnicity, ability, sexual orientation, or social status. I trust in the power and mystery of the Holy Spirit, who I know as the Mother of Creation, who guides, empowers, and journeys with us. She enables us to see and discern God's will for our lives and the world while revealing God at work in all of Creation.

As a Black woman raised in the US, a Womanist and Liberation hermeneutic informs how I engage with Scripture. I acknowledge the authority of Scripture and interpret it through the lens of reason, tradition, and experience, recognizing that — while inspired by God — it is also a product of people, time, and culture. I joyfully affirm the sacraments of Baptism and the Lord's Supper, which are signs of God's covenant love. Through baptism for both believers and their children through God's sovereignty, we are reminded of the death and resurrection as we are renewed. Like Baptism, the Lord's Supper is a visible sign of God's invisible grace and unconditional love available to all who profess faith in Christ. Through this sacrament, we are invited to remember and reflect on God's liberation action from generation to generation as we communion with one another

I appreciate the Reformed tradition of the Presbyterian Church, emphasizing communal discernment and voice that builds and sustains the covenant community by the grace of God and the work of the Holy Spirit. Short Biography of Thomas Gordon Rennard

I'm a Jersey boy who came west for seminary, met and married a Californian and have stayed since. I came to Fuller Theological Seminary to prepare to be a mission co-worker. I had left the Army which paid for my undergraduate degree at Wheaton College and required four years of service, as an artillery officer.

While in seminary I was appointed a volunteer in mission/seminary intern with the Presbyterian Church USA for a year of service in Lesotho, Southern Africa. While there I had a deep realization that "I was a pastor" and returned for my final year of seminary to prepare for pastoral ministry through the guidance of Knox Church/Pasadena and the Presbytery of San Gabriel.

I was ordained by the Presbytery of San Fernando in 1989 to be the associate pastor at First Presbyterian Church of Granada Hills. I took a sabbatical in 1993-4 and then was made Stated Supply of Community Church, El Monte in 1995, and served the Pasadena Church as Interim Associate Pastor (1996-1998) and San Marino Community Church Presbyterian in 1998. I became a trained Interim Specialist in 1999 while the Interim Pastor at Claremont Presbyterian Church (1999-2000). I directed Field Education at Fuller Seminary from 1995-1999. In 2000-2001 I was the Interim Pastor at the Union Church of Lima, Peru and was the Interim Executive Presbyter of the Presbytery of San Gabriel from 2001-2005.

In 2006 we moved to San Bernardino where I recruited students for San Francisco Theological Seminary/Southern California and directed the local Habitat for Humanity affiliate in San Bernardino where we built two houses. In 2007 I was installed as the pastor of Community Presbyterian Church of Crestline and then served interims or bridges beginning in 2013 in Redlands, Temecula, Hemet, and Big Bear. In 2019 I was called to the Transitional Stated Clerk of the Presbytery of Riverside. I retired from presbytery and congregational service on January 1, 2023. Since January I served in the Food Ministry at First Presbyterian Church of San Bernardino and sung in the choir. My wife, the Rev. Sandy Tice, and I moved to Monte Vista Grove Homes on July 3rd.

Statement of Faith Thomas Gordon Rennard

Presbytery of San Gabriel Executive Commission Report to the Presbytery February 3, 2024

The San Gabriel Presbytery Executive Commission (PEC) met on Zoom on Tuesday, December 12, 2023, and Friday, January 12, 2024, with a quorum present, and makes the following report to the Presbytery.

FOR INFORMATION

- 1. On behalf of the Presbytery, the Executive Commission approved the housing allowance for teaching elders on Presbytery staff. See attached.
- 2. On behalf of the Presbytery, in response to a recommendation from the Administration and Finance Committee, the Executive Commission voted to utilize the proceeds of the St. Andrew's Presbyterian Church property sale as follows:
 - commit up to \$1.2 million as a matching grant for Phase One of the renovation of the Eagle Rock Presbyterian Church property as the home base for Interwoven
 - establish an unrestricted account of \$500,000, named after St. Andrew's Presbyterian Church.

Background: The net proceeds of the sale of the St. Andrew's Presbyterian Church property was \$1,707,728.85, received on November 13, 2023. The full amount was immediately invested in a 6-month treasury bill, earning 5%. It is expected that this 6-month investment will yield \$42,700. The most recent estimate for the renovation of the sanctuary/fellowship hall building of Eagle Rock Presbyterian Church (ie, Phase One) is \$1.6--\$2.0 million. Harlan Redmond has begun talking to prospective donors, and projects that a match of \$1.2 million will give him room to raise funds to cover not only the renovation costs, but an added 10% to help with operating expenses of the Interwoven new worshiping community.

The Administrative Commission for St. Andrew's Presbyterian Church requested the establishment of an unrestricted account to be named as a legacy to that congregation.

- 3. The Commission voted to open every Presbytery meeting with a land acknowledgement, in compliance with General Assembly guidance and in honor of our Indigenous hosts, the Gabrieleño/Tongva San Gabriel Band of Mission Indians.
- 4. On behalf of the Presbytery, the Executive Commission approved Elder Carrie Kohler as Acting Stated Clerk for Administration, effective January 15, 2024. Her contract runs until April 30, 2024, for \$45/hour at approximately 25%-time, with a minimum of 12 hours/week. In compliance with the Presbytery bylaws, the Personnel Committee expects to present Elder Kohler for election for a 3-year term at the Presbytery meeting on April 16, 2024.
